**Code of Conduct  
For  
Governor General's Youth Award (GGYA) Volunteers**

Purpose: To ensure that GGYA volunteers are aware and committed to the value and vision of the Governor General's Youth Award in conjunction with the Duke of Edinburgh's International Award.

Volunteers with active status in the GGYA Programme are subject to the following:

1. All volunteers must be 18yrs or older.
2. Refrain from the use of obscene and abusive language.
3. Smoking (of any kind of substance) is prohibited.
4. Consumption of alcoholic beverages is not allowed.
5. No fraternization and inappropriate relationships with participants.
6. A volunteer shall not display or engage in no intimate contact or actions that are sexual in nature during GGYA events.
7. Volunteers are not allowed in areas designated for the opposite sex.
8. Volunteers must conduct tutoring, mentoring and coaching in open public view or in the presence of another adult volunteer.
9. All relevant GGYA fees must be recorded and paid into the NAA office. Volunteers must be given a receipt for all payments.
10. Volunteers must protect the name of the GGYA at all times.
11. Accept orientation and training as is necessary in order to provide a quality service.
